but extreme effects, and often argued to be lifestyle dependent – such as lung cancer or diabetes; b) Effective use of health human resources, such as front line workers and in particular, General Practitioners (GPs) the reliance on GPs and nurses as referral and diagnostic tools presents challenges in terms of workload and work quality. Evidence suggests often success diagnostic rates of GPs are lower than of electronic software applications; c) Equity and universality, health systems strengthening, and price regulation - how health systems respond to universal coverage and how incentives can be put in place to safeguard quality and access to affordable health services. This team can provide the analysis of market and sectoral behaviour and outcomes of health insurers, private health providers, and the analysis of patients' behaviour and which can lead such global discussions.
